The files contain correspondence, lists, notes and publications covering the 1964 national election, with most of the materials being about Lyndon B. Johnson's Presidential campaign. The materials include letters to and from Democratic campaign supporters, other campaign workers, government officials, and the general public; mailing lists; and printed campaign materials. The files also include lists of people recommended for political appointments that were forwarded to the Democratic National Committee for clearance.
