Scope and content note:

This series contains correspondence, telegrams, memorandums, reports, papers, lists, speeches, statements, agendas, and meeting minutes. There are four subseries.

The first subseries relates to the Committee on Nuclear Proliferation and includes material on nuclear weapons, nuclear nonproliferation, a comprehensive test ban treaty, nuclear testing, peaceful uses of atomic energy, and arms control. Geographic regions represented include the Soviet Union, China, France, German, India, Japan, and the United Kingdom.

The second subseries relates to the White House Conference on International Cooperation and concerns the declaration of 1965 as the "Year of International Cooperation."

The third subseries relates to the President's Committee on the Warren Report. This subseries includes material on the establishment of the committee, its meetings, and its report, as well as material on the release of the Warren Commission Report, disclosure of the records of the Warren Commission, and public reaction to the Warren Commission Report.

Finally, the fourth subseries includes material concerning the Special Committee on U.S. Trade Relations with East European Countries and the Soviet Union.
