

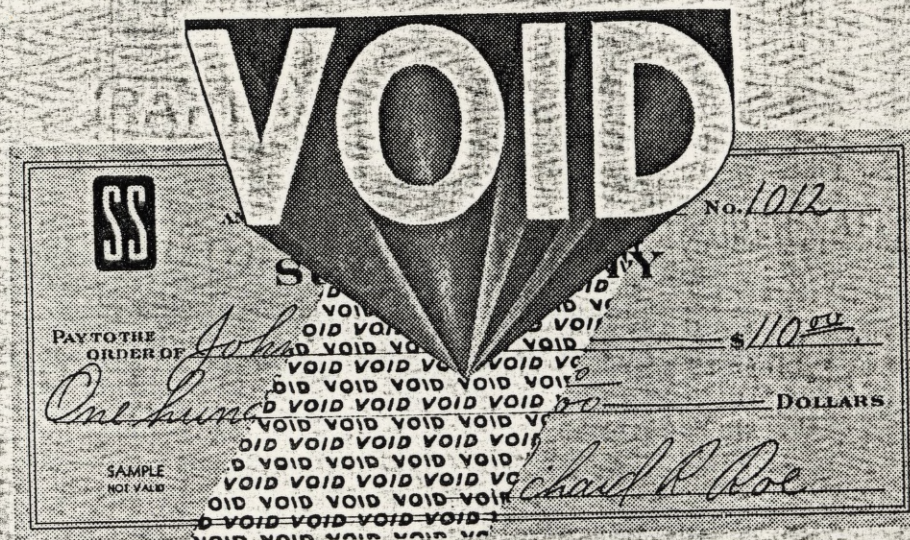
THESE self-cancelling Super-Safety Checks are the safest checks any bank can furnish. If someone attempts to alter one by using ordinary ink eradicator the surface vanishes and countless VOIDS appear cancelling the check forever. Erasure leaves a glaring white spot—unmistakable evidence of tampering. The effectiveness of these safety features is guaranteed by insurance protecting every user of Super-Safety Checks from losses caused by alteration. *Always write your checks in ink, indelible pencil, or with a checkwriter.*

FOR YOUR PROTECTION

As a user of the Super-Safety Checks in this book you are insured against losses caused by alteration of the date, number, name of payee or alteration of the written amount by chemical ink eradicator in accordance with the terms of a Super-Safety check alteration insurance policy held by your bank. If you suffer a loss caused by any of the above frauds, notify your bank immediately. *Below you see what happens when ordinary ink eradicator is used on a Super-Safety Check.*



PRECAUTIONS TO OBSERVE IN WRITING CHECKS

1. Begin at the left of every line.
2. Fill in blank spaces by drawing lines through them.
3. Write the amount with a mechanical checkwriter whenever possible.
4. Avoid flourishes in your handwriting. Simple writing is the hardest to forge.
5. Destroy all checks erased or marred in drawing, mark the stubs VOID.
6. Never make out checks to cash or bearer.
7. Never sign blank checks.
8. Keep unused checks under lock and key.
9. Guard your cancelled checks carefully—they carry your signature—make perfect "copy" for forgers.
