Biographical sketch:

Robert Scott Shellow was a management service company executive and consultant. Shellow joined the Commissioned Corps of the United States Public Health Service in Bethesda, Maryland, advanced through the grades to commander, and worked in the field of psychology with the United States Bureau of Prisons. Shellow also worked as assistant deputy director for research at the National Advisory Commission on Civil Disorders, director of pilot programs at the District of Columbia Department of Public Safety, professor at Carnegie Mellon, president of IMAR Corporation, managing director at Cross-Continent Associates, Ltd., and managing director of Professional Security Consultants International.

Scope and content note:

This collection consists of reports, correspondence, notes, newspaper clippings, and publications collected by Robert S. Shellow related to his service on the National Advisory Commission on Civil Disorders. The papers cover the Commission's budget, organization, assignments, meetings, research, and reporting. They include materials on the causes, costs, effects, and prevention of civil disturbances, as well as materials on individual incidents, the nature of different types of civil disturbance, areas affected by rioting, and the participants of civil disorders.
