The entire executive file consists of cross reference material. The general file contains two original documents relating to fire insurance policies, -1".
- IS 5-2 **VETERANS SERVICE**
Material concerned with dividend payments on veterans' insurance and the possibility of increasing the amount of life insurance available to servicemen in Vietnam. This file contains a great deal of cross reference material to LE/IS 5-2 and LE/VA. The entire general file, consisting of material relating to decisions on veteran's insurance cases, is restricted, 2¼" (2" restricted).
